## **GeM – Forward Auction**

Maha Mumbai Metro Operation Corporation Limited (MMMOCL), a Govt. of Maharashtra, PSU invites the prospective bidders to participate in the e-Auction for disposal of used tyre scrap on "AS IS WHERE IS BASIS" with a reserve/floor price of **Rs. 542000/-** (Rs. Five Lakhs Forty Two Thousand only) as per attached Annexure-A.

### **1. The pre-qualification of the bidders is as under:**

- a. The bidder should have GST registration with the concerned Department of Government of India.
- b. The bidders should provide the Copy of GST Registration and PAN card.
- c. The bidders who are interested may complete pre-bid inspection of above-mentioned scrap lying at the premises of Mumbai Monorail Depot, Next to Wadala RTO, Near Anik Bus Depot, Wadala (E), Mumbai. However, if scrap inspection has been carried out by the bidder, he needs to submit a certificate as per Annexure-B, duly certified by the MMOCL officials, during the inspection.
- d. Waste material scrap also needs to be collected along with the scrap lots which is mandatory & shall be in Vendors scope.
- e. The bidder must not be blacklisted by any Department of the Government. An undertaking regarding non-blacklisting of the bidder by any Government organization must be furnished by the bidder in the e-Auction document in the format given in Annexure-C.

**Note: Before submission of the bid, the bidders must verify the eligibility criteria and ensure fulfillment of all the terms and conditions. In the absence of proof of supporting copies of documents/ certificates under eligibility criteria above, the bid is liable to be rejected.**

### **2. Bid Submission through e-Auction:**

- a. Bidder should submit the bid through 'e-Auction' via 'Forward Auction' available on GeM.
- b. Price should be given in INR figure only.
- c. In the e-Auction, the bidder needs to quote the basic price not less than the reserved/floor price.

## **Instruction to Bidder (ITB)**

- a. **Pre-bid Inspection:** The pre-bid inspection may be carried out before participation. The prospective bidders will be required to fill the Annexure 'B' of the subject Auction document and the same is required to be submitted along with the quotation on GeM portal.
- Location:** Mumbai Monorail Depot, Next to Wadala RTO, Near Anik Bus Depot, Wadala (E), Mumbai - 400037, Maharashtra, India.
- Duration:** Time duration for inspection of material will be 7 working days from date of float e-Auction.
- Time:** Working hours for the inspection will be 09.00 AM to 5:00 PM.

- b. MMMOCL reserves the right to accept/reject the offers or cancel the whole e-Auction proceedings without assigning any reason whatsoever.
- c. MMMOCL shall not be responsible for delayed submission or non-submission of bid due to any reason whatsoever. The bidders are requested to submit the bid much before date & time of submission, failing which MMMOCL shall not be responsible for any such technical problem.
- d. Any attempt of direct or indirect negotiations on the part of the bidder with the authority to whom the bid has been submitted or authority who is competent to finally accept/reject the same after the e-Auction has been submitted or any endeavour to secure any interest for an actual or prospective bidder or to influence by any means, the acceptance of a particular e-Auction will render the e-Auction liable to be rejected.
- e. The items shall remain, in every aspect, at the risk of the successful bidder from the date of acceptance letter. This office shall not undertake any liability whatsoever for the safe custody, protection or preservation after the issue of acceptance letter. A lot has been put up for e-auction, subject to change by nature's wear and tear. No complaint regarding the quality or description of the materials sold will be entertained once the bid has been accepted.
- f. **Payment:** The successful bidder will have to make 100% payment (including GST, if any) through 'Bank Draft/NEFT in favour of "Maha Mumbai Metro Operation Corporation Limited" payable at "Mumbai" within 10 days from the date of GeM intimation letter.

Delivery has to be taken by the successful bidder within 10 (Ten) calendar days (called free delivery period) from the date of the acceptance letter (excluding the date of issue of the acceptance letter). The lifting of the scrap tyres will be allowed only the due bid amount is credited to the bank account of this office as per the following details.

- g. The successful bidder, after making full payment shall take delivery of the items within 10 days of delivery order to be issued by MMMOCL upon receipt of 100% payment. Necessary documents will be provided at the time of delivery of the items.
- h. In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the material within the scheduled period, this office shall not take responsibility for safe custody of the material.
- i. In case, the successful bidder is not able to lift the articles within delivery period, he/she may request for an extension. Such extension(s) may be granted after levying a ground fee @ 1% (percent) of the sale value per day.
- j. No damage shall be caused to the existing property of the office or any other offices in the premises while goods/material will be removed under the supervision of designated officers of this office. The material will have to be removed within the time stipulated in the acceptance letter. No extension of time will be given under ordinary circumstances. However, an extension of time may be granted provided convincing the satisfactory reasons for such delay is given in writing by the successful bidder. Delay, beyond the stipulated time, may entail cancellation of the award/order.
- k. All the charges i.e. loading, unloading, and transportation to be incurred in the course of lifting of item from the designated place shall be borne by the successful bidder.
- l. The scrap listed is on "AS IS WHERE IS BASIS" and "NO COMPLIANT BASIS" no complaint regarding the quality, quantity or composition of the materials will be entertained.
- m. The scrap quantity listed for sale maybe 25% more/less when compared with the material quantity released.
- n. The MMMOCL reserves the right to accept or reject any or all the offers of e-Auctions without assigning reasons thereof.
- o. In case of any dispute, the decision of the Director (Maintenance), MMMOCL, Mumbai shall be final and binding on all parties.

### **3. GUIDELINES:**

- a. Contractor shall make necessary arrangements as regards Material handling equipment labour & weighing scale arrangements during the collection of scrap materials and would be in his scope of work.
- b. Contractor is prohibited for removing Nonconforming goods, including:
  - i. Any goods containing hazardous material as defined under federal or state laws and regulations.
  - ii. Any single piece of equipment with a radiation level exceeding the applicable state level.
  - iii. Any vessel and/or heater coated with asbestos containing insulation
- c. **Weight and Measurement:** Each load of scrap metal purchased shall be weighted on the work site scales or in the event the work site does not have scales on location, at a bonded public scale (agreed to by owner and contractor) and all scale tickets shall include the following:
  - i. Tare weight and date of weighing
  - ii. Gross weight and date of weighing
  - iii. Net weight of miscellaneous scrap metal

- iv. Point of origin of the scrap metal
  - v. License number of tractor and float trailer
  - vi. Signature of owner representative or bonded weigh person
- d. In connection with this agreement tonnage shall be equal to gross weight minus tare weight. The gross weight shall consist of the combined weights of the tractor, trailer, loaded scrap container, full fuel tanks, with no drivers or helpers on board the vehicle(s). Tare weight shall consist of the combined weights of the tractor, trailer, empty scrap container, full fuel tanks, with no driver or helpers on board the vehicle(s).
  - e. The tenderer shall have no right for rejection of any part of whole of the scrap tires and shall have to accept the same at the mentioned rates as is and where it is basis". The MMMOCL shall not be responsible for any fault, defect or errors in the description of scrap tires sold and it shall be clearly understood that the items offered for sale and accepted by the successful tenderer in their existing condition only.
  - f. The scrap tyres should be removed by the successful tenderer within 10 days from the date of acceptance of tender. The date and time given for lifting of the Unused tyres shall be strictly adhere to and if the tenderer fails to lift them within the period specified, he shall have to bear the loss if any to MMMOCL. The decision of the MMMOCL will be final & binding on the contractor. Regarding the grant of an additional period for lifting scrap tires as well as other matters related to tender in all. Segregation of lot items is not allowed within the site premises. The bidder shall necessarily lift the entire lots.
  - g. The contractor needs to arrange for the PPEkits/accessories of the workman/agency personnel hired by him to execute material dismantling/lifting and ensure that they have their Aadhar/Voter ID Card. If not so, MMMOCL shall be restricting their entry to the site premises.
  - h. Loading/Unloading shall be carried out by the contractor at his own cost & risk. All tools and tackles, Labour, Forklifts and crane, etc shall be arranged by the contractor at their own cost.
  - i. The contractor shall be solely responsible for the unethical practices of the workman/agency personnel hired by him for material dismantling/lifting purposes and shall ensure immediate settlement of any applicable penalties.

#### **4. SAFETY RULES & REGULATIONS OF THE COMPANY:**

- a. Before start any vehicle, make sure about valve and blind closure and check around the vehicle.
- b. Smoking and carrying match box or cigarette lighter or any other source which may produce naked flame is strictly prohibited in battery limit.
- c. Nobody should rest sleep on road / under vehicles and take bath inside plants.
- d. Speed limit of vehicles should be maintained as per Company's rules
- e. Use required safety appliances tools and tackles during loading /unloading of material.
- f. Only proper license holder driver should drive the vehicle. Maintain rules and regulations about the traffic.
- g. While reversing, the cleaner should direct the driver.
- h. All documents include license should be kept handy and to be shown whenever demanded.

- i. Other precautions, instructions displayed at Entry Gate, given by Security persons and other officers are to be followed.
- j. No vehicle should be overloaded. The vehicle should be driven on specified road only and nobody should loiter around in other places.
- k. While loading / unloading proper wheel blocks should be used. Loading & tying of bags to be ensured so that bags do not fall.
- l. No vehicle should be loaded or unloaded while the engine is running.
- m. Accidental policy will be in scope of tenderer.

## 5. SAFETY REQUIREMENTS:

Contractor shall make himself fully conversant with MMMOCL rules, regulations, orders, prohibitions and ground rules in force from time to time in respect of discipline, entry into, exist from and being working and smoking within Seller's office and factory premises and will ensure and enforce their strict observance and adherence by Contractor's and his employees, labourers, agents and contractors. In case of any breach or failure to observe or adhere to any such rules, regulations, orders, prohibitions or ground rules, MMMOCL shall be entitled to take such disciplinary or other action and Contractor will be liable for any loss, damage or injury caused as a result of such breach of failure. Scrap Buyer shall ensure to provide Safety Helmets, Shoes, Hand Gloves, Safety Goggles, etc. to their Supervisors and Labourers engaged for cutting and/or lifting of material. Contractor shall ensure for valid Driving License along with RTO documents with vehicle itself, engaged for lifting of material.

**Items sold "AS IS WHERE IS BASIS" and "NO COMPLAINT BASIS",** no complaint regarding quality, quantity or composition of the materials will be entertained.
